Statement of Purpose

REACH is a Christian organization dedicated to promoting home schooling. Our purpose is to strengthen the homeschool community by providing support, encouragement, and learning opportunities at affordable costs to homeschooling families.

REACH is a group of parents pooling our resources in order to teach our children a wide variety of enrichment and academic subjects. **REACH** is neither a school nor a model of classical home schooling. These classes meet only one day a week and are not intended to teach all that the students need to learn. **REACH** is NOT an umbrella school. **REACH** admits all homeschooling students.

Statement of Faith

The Bible is the inspired and infallible Word of God and constitutes His completed and final revelation to man. The Bible, in its original autograph, is without error in whole and in part, including theological concepts as well as geographical and historical details.

God is a Spirit, infinite, eternal, and unchangeable in His being, wisdom, power, holiness, justice, goodness, and truth. There is but one God, the living and true God. There are three persons in the Godhead, the Father, the Son, and the Holy Spirit, and these three are one God, the same in essence, equal in power and glory. Jesus Christ was God come in human flesh being fully God and fully man, except without sin.

Additional Information

- Children must be in a classroom with a teacher or accompanied by a parent at all times while on campus. At no time, may any child under the age of 16 be left unattended.
- **Once applications have been accepted, there is a \$10 charge for each change made after the registration deadline.**
- An effort has been made to finalize the class schedule, however, some classes could be subject to change. You will be notified if such is the case (there will be no charge to the parents for course changes made by REACH or the host facility).
- Certain classes will require you to purchase the assigned text or supplies. Specific titles will be listed in the course descriptions.

Refund Policy

We understand that due to changing circumstances, families sometimes need to drop activities from their schedule. However, because we make financial commitments according to the number of students enrolled, we are unable to issue refunds for REACH programs. In the event of unavoidable changes due to health, relocations, etc..we will work with you as much as we possibly can.
